

Move-In Checklist

Dear New Tenant,

Prior to moving in, we at Brands Capital took photos of your unit and inspected it for any major repair or cleaning needs. Oftentimes, however, there are small defects such as stains and scratches that are not financially worthwhile for us to repair. While we will not be making these small repairs, it is important for us to note these minor defects so that you are not charged for them when you move out. It is essential, therefore, that you complete our move-in checklist to document any concerns that you might have about your unit. Remember, if this checklist is not returned to us within **3 business days** of your move-in, Brands Capital may see fit to charge you for any undocumented damages when you move out.

Please be clear and concise in your comments. Additional space is provided on the last page of this checklist if you need to explain anything in detail. You can make a checkmark or write "Fine" or "OK" in the box when you find an item in good condition. **Management will assume no defects were found for any items in which boxes were left empty**.
